This puppy/dog is in good health to the best of my knowledge. It is up to date on shots and de-worming and appears to have no signs of sickness. Any known imperfections have been disclosed.

Health Guarantee:

The purchaser has 72 hours to have the puppy/dog checked by a licensed vet. Upon finding an infectious disease, the purchaser must notify breeder immediately and has an additional 24 hours to return the puppy/dog for a full refund. In the instance that you wish to keep the puppy, Breeder and Purchaser may come to the agreement that Breeder will pay for medicine and necessary medical attention. This will not include initial visit or follow up visits and will not exceed the purchase price. Any illness or imperfection that was disclosed before purchase is not valid for return. Failure to have the puppy/dog checked within the 72 hour period, failure to contact breeder concerning illness within 72 hour period, or failure to have other animals in your home that the puppy/dog will be exposed to checked/vaccinated for infectious disease will void the guarantee. A letter from purchaser's vet is required and breeder's vet confirmation. Infectious disease does not include parasites (worms, ear mites, fleas, coccidia or giardia etc.). In the event the puppy/dog has coccidia or giardia, Breeder will pay for medicine only (up to \$15.00), to treat the puppy/dog, not to include vet visits or other. In addition, breeder will replace puppy/dog with one of equal value when available if it is diagnosed with a life threatening genetic illness within 1 year from date of purchase and if the following conditions are met: Purchaser must notify breeder immediately of any illness, Purchaser must have followed instructions from licensed vet and Purchaser must allow post mortem exam by vet of breeder's choice within 24 hours of death, if death occurs. If hereditary illness is confirmed, breeder will take responsibility for post mortem exam; otherwise, purchaser must take responsibility. Breeder is not responsible for ANY medical, travel, upkeep or shipping costs. In addition to all the following, your puppy has had an excellent start in life. Puppies are fed high quality puppy food and are started on NuVet Plus Vitamins. Because of the variety and quality of dog foods available (and all canine illness are NOT covered by vaccination), we require that your pup be kept on "NuVet Plus" canine vitamins for a minimum of 1 year from the date of purchase. This nutritional supplement is only available through breeder or veterinarian recommendation. You are expected to order this within the 72 hour period. Orders are tracked. The order line is 1-800-474-7044. Your order code is 96625. This health guarantee will be considered null and void if you do not keep your pet on this supplement.

Purchaser's Responsibilities: Purchaser assumes all responsibility for the health, temperament, behavior, appearance and total well being of the puppy/dog upon possession. Breeder does not guarantee perfect confirmation, size or temperament. Each puppy/dog is eligible for registration either with the AKC, APRI or CKC. It is the purchaser's responsibility to register the puppy/dog. Registration papers are given when the puppy/dog is paid for in full unless there are circumstances beyond our control. In no way is the breeder responsible for registration after that point. A puppy is a lifelong commitment. My intentions are to sell a puppy to its forever home. In the instance that the purchaser can no longer keep the puppy/dog, purchaser must give notification to breeder. Breeder will gladly take any puppy/dog back to find a suitable home for it if purchaser can not. No monetary compensation will be given. NO puppy/dog

is to ever be handed over or seized by an animal shelter or euthanized for any other reason than medical. Purchaser must notify breeder upon neglect/cruelty charges and first rights belong to breeder on taking the puppy/dog back. Proof of medical condition may be asked for if puppy/dog is euthanized. If a medical condition arises that purchaser can not afford (surgery etc.) and considers euthanasia, breeder has first rights to take back the dog permanently and become responsible for the puppy/dog.

Litigation: If purchaser brings litigation against breeder it will take place in the county and state of the breeder. If the breeder is found not at fault, all fees incurred are the responsibility of the purchaser.

When checked, this means puppy/dog is being sold with limited registration and a spay/neuter contract. This puppy/dog is not to be used for breeding. Any violation will result in legal action.
